**POLL RESULTS OF THE
2024 FIRST EXTRAORDINARY GENERAL MEETING
HELD ON MARCH 19, 2024**

At the 2024 first extraordinary general meeting (the “EGM”) of Linekong Interactive Group Co., Ltd. (the “Company”) held on March 19, 2024, the proposed resolution set out in the notice of EGM dated February 28, 2024 was taken by way of poll.

As at the date of the EGM, the total number of issued shares of the Company was 367,974,964 shares, which was the total number of shares entitling their holders to attend and vote on the resolution proposed at the EGM.

There was no share entitling its holder to attend but to abstain from voting in favour of the resolution proposed at the EGM as required under Rule 17.47A of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”) and there was no share held by shareholders that are required under the GEM Listing Rules to abstain from voting on the resolution proposed at the EGM. None of the shareholders have stated their intention in the circular of the Company dated February 28, 2023 to vote against or to abstain from voting on the resolution proposed at the EGM.

All the directors of the Company have attended the EGM, and the Company’s share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the EGM.

The poll results of the resolution proposed at the EGM are as follows:
