ESTABLISHMENT OF THE LK CRYPTO DIVISION TO
ACCELERATE THE DEPLOYMENT OF WEB3
AND RWA CRYPTO ASSETS**

The board of directors (the “**Board**”) of Linekong Interactive Group Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) announces that the Group has established the “LK Crypto” division to accelerate the deployment of Web3 and RWA (real-world asset on-chain) assets.

Amid the rapid integration of digital assets and Web3 technologies into global industries, the Group maintains strong confidence in the long-term value and strategic importance of Web3. This optimism is further reinforced by the continuous breakthroughs in key areas such as RWA (Real-world Asset on-chain) and stablecoins, which are accelerating Web3’s transition from concept to large-scale adoption — positioning it as a core driver of the next technological revolution and asset transformation.

To further enhance the Group’s business structure, consolidate its Crypto assets and Web3 resources, and capitalize on the historic opportunities brought by Hong Kong’s Web3 policies, we hereby announce the launch of the “LK Crypto” division, which is the core platform for executing the Group’s Web3 strategy. This division will oversee all Web3 and Crypto-related businesses under the Group, including (i) managing the Group’s mainstream Crypto holdings (i.e. Bitcoin, Ethereum and Solana); and (ii) Crypto asset management for companies which the Group has invested in (i.e. LK Venture, Marsbit, Element, etc.).

Through this strategic restructuring, we will strengthen our investments and execution across Crypto asset allocation, Web3 project incubation, content ecosystem development, and global partnerships — all guided by the principles of compliance, transparency, and long-term commitment. Our goal is to establish a centralized Web3 capability hub at the Group level.

Shareholders and potential investors of the Company should note that any Cryptocurrencies that the Group may purchase or sell will depend on market conditions and will be made at the Board's discretion. The Cryptocurrency market is volatile in the near-term and the prices of Cryptocurrencies may be subject to fluctuations.
