Reference is made to the annual report (the “**Annual Report**”) of Linekong Interactive Group Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) for the year ended 31 December 2024, which was published by the Company on 25 April 2025. Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Annual Report.

In addition to the information provided in the Annual Report, the board of directors (the “**Board**” or “**Directors**”) of the Company would like to provide further information to the paragraph headed “Significant Investment held during the Reporting Period” in the section headed “Management Discussion and Analysis”.

The Group holds significant investments, which include equity interests in Fuze and Jikebang Fund. As at 31 December 2024, the Company held 87,045,455 shares, equivalent to approximately 36.82% of the issued share capital in Fuze. Jinkebang is a private equity fund and the Company’s initial investment was RMB30,000,000, which was equivalent to 25.77% of the fund.

The above information is supplemental to the Annual Report and does not affect other information in the Annual Report. Save as disclosed in this announcement, the contents of the Annual Report remain unchanged.
